

Michigan's New Auto Insurance Law

Mandatory Coverages

- Property Protection Insurance (PPI)
- Personal Injury Protection medical coverage (PIP)
- Residual Liability Bodily Injury and Property Damage (BI/PD)





Key Changes

- Provides drivers with a choice on the level of medical coverage
- Lowers costs while maintaining the highest benefits in the nation
- Increases consumer protections

Most changes take effect for policies issued or renewed after July 1, 2020.







PIP Medical Coverage: Your Choices

PIP MEDICAL COVERAGE LEVELS AVAILABLE TO MICHIGAN DRIVERS:

- Unlimited coverage per person per accident
- Up to \$500,000 in coverage per person per accident
- Up to \$250,000 in coverage per person per accident
- Up to \$250,000 in coverage per person per accident with exclusions
- Up to \$50,000 in coverage per person per accident (Medicaid)
- Medical PIP opt-out (Medicare)

Lowers Costs, Maintains Benefits

REQUIRED PIP RATE REDUCTIONS - JULY 2, 2020

- Unlimited PIP Option avg. 10% reduction
- \$500k PIP Option avg. 20% reduction
- \$250k PIP Option avg. 35% reduction
- \$50k PIP Option avg. 45% reduction







Increases Consumer Protections

- Elimination of Certain Non-Driving Factors
- Fraud Investigation Unit
- Prior Approval
- Fines and Penalties



Choosing PIP Coverage

WHEN CHOOSING PIP MEDICAL COVERAGE, DRIVERS MAY NEED:

- Information from their health insurer or employer identifying individuals covered under their health insurance.
- A statement as to whether your health policy complies with the law which means that it does not exclude or limit auto accident injuries and has a deductible of less than \$6,000.
- Medicare and Medicaid participants may also need proof of enrollment.

THE PURPOSE OF THIS FORM

The purpose of this form is to explain the choice you have regarding your **Personal Injury Protection (PIP) medical** coverage and to assist you in making that choice. Read this form carefully because the choice you make will have financial consequences.

Personal Injury Protection (PIP) Medical Coverage Explained

Personal Injury Protection (PIP) pays allowable expenses for your care, recovery, rehabilitation, wage loss and replacement services. PIP coverage also includes some funeral expense benefits and survivor's benefits which are paid to your dependents if injuries from an auto accident result in your death. This form allows you to select the level of PIP medical coverage you want included with your auto policy.

This form is divided into three sections, which are described below.

- Section A will review your PIP medical coverage options and the risks and benefits of each option.
- Section B will ask you to choose ONE coverage option.
- Section C will ask you to certify your choice and acknowledge the information within this form.

NOTICE

You <u>must choose</u> the level of **PIP medical** coverage you wish to have under your auto policy. If you do not make a selection from the options listed:

- Your policy will be issued with unlimited PIP medical coverage; AND
- You will be charged the appropriate premium for this coverage.

Definitions

The terms in bold letters throughout this form are defined below for informational purposes only and are not intended to limit or expand coverage that may be available in a particular policy.

Applicant means a person who has submitted an application for insurance but is not yet insured under a policy.

Attendant care means services to assist an injured person with tasks they would normally do for themselves (e.g., eating, bathing, dressing, grooming, and medication administration). It may also involve supervision or other types of support.

Excess attendant care means additional coverage purchased for attendant care above the PIP medical coverage limit selected for your policy.

Michigan Assigned Claims Plan is a program that may pay benefits to people injured in an accident involving a motor vehicle when there is no applicable auto insurance policy.

Named insured means the individual(s) named in an insurance policy.

Personal Injury Protection (PIP) Medical is coverage under an auto insurance policy issued in Michigan that pays allowable expenses for medical care, recovery, rehabilitation, and some funeral expenses.

Qualified health coverage means either of the following:

- Health and accident coverage that does not exclude or limit coverage for injuries related to auto accidents and has an annual individual deductible of \$6,000 or less; OR
- Coverage under both Medicare Parts A and B.

Medicaid and health care sharing ministries are examples of coverages that are NOT considered qualified health coverage.

Resident relative means a relative of either you or your spouse who lives in the same household.

Above is a list of targeted neighborhoods in District 2. These areas are part of our persuadable census tracts where we need an increase of 5-6% above 2010. They have high occupancy but are performing below what they did in 2010.

Two important things about these areas:

- 1. We would like to **put a specific action in place in specific neighborhoods** and then we can measure its impact by looking at
 the census response rate for that area in the following days. If there's
 an increase, we replicate it in other areas, if not, we do another
 action.
- 2. Not asking you to limit your actions to only these neighborhoodsobviously leaders in any neighborhood that show initiative need to be supported. So, If they do an action, we need to measure its impact

WHAT ARE THE ACTIONS:

We published these in the first district standings. These are suggestions to start but we want to go with what works, so these will change based on results and impact on response rates:

SUGGESTED ACTIVITIES:

- Start phone trees/phone banking among neighbors;
- Organize a Tweet storm; send email blasts to residents, members
- Text-a-thon with City Council member, District Manager and district block clubs
- Promote on NextDoor
- Post photos, videos on Social Media; Facebook live event or Zoom Block Party
- Place posters in local grocery stores or kicker cards in food boxes and take out;
- Distribute lawn signs to neighbors (available after May 15)
- Encourage people to sign up online: my2020census.gov or call toll free number: 844-330-2020 (English); 844-468-2020 (Spanish); 844-316-2020 (Arabic)


